## Limited Warranty

SILVER STREAK TRAILER COMPANY warrants for a period of one year to the original owner the repair or replacement at the option of THE COMPANY any part of the Trailer except tires, batteries, appliances and components manufactured by others, which in the judgement of THE COMPANY is defective in material or workmanship.

This Twelve Month Period of Warranty is deemed to begin on the date of RETAIL DELIVERY as recorded on the ATTACHED WARRANTY REGISTRATION and only when it is mailed to SILVER STREAK within 30 days bearing the authorizing signature of THE FRANCHISED SELLING DEALER and the ORIGINAL OWNER!

All that is required is proper maintenance and operation of the trailer as explained in the SILVER STREAK OWNER'S MANUAL AND ACCOMPANYING APPLIANCE BOOKLETS, and return for WARRANTY SERVICE TO THE SELLING DEALER, THE SILVER STREAK FACTORY SERVICE CENTER; or if traveling or having moved and needing emergency repairs TO ANY SILVER STREAK DEALER OR APPROVED SERVICE FACILITY AFTER HAVING RECEIVED AUTHORIZATION FROM THE FACTORY SERVICE MANAGER AT (213) 444-2646 by prepaid call.

REGISTRATION OF Appliance and Component Warranties with their respective Manufacturers is the responsibility of the ORIGINAL RETAIL OWNER. THIS LIMITED WARRANTY is not intended to replace valid warranties on appliances and components manufactured by others when installed by SILVER STREAK TRAILER CO., it only offers to assist the original owner in exercising those valid warranties throughout the term of this Warranty. (See Appliance Warranty Authorized Service Center locations in their respective Booklets.)

There is no other expressed warranty; and any implied warranty of merchantability or fitness is limited to normal travel trailer use and stated weight capacities for only the 12 month duration of this written Warranty.

To the extent allowed by law, neither SILVER STREAK TRAILER COMPANY nor the selling dealer shall have any responsibility for loss of use of the trailer, commercial loss, loss of time, inconvenience, or consequential damages.

Some States do not allow limitations on how long an implied warranty lasts or the exclusion or limitations of incidental or consequential damages, so the above limitation may not apply to you.

This Warranty gives you specific legal rights (when original owner) and you also may have other rights which vary from State to State.
